ELIGIBILITY: All Amateur and Professional Artists 16 years and older, living in the state of Kansas. All work **must be original** and not previously exhibited in a R.O.A.R show. Each entry will be judged only in its own category. NOTE: The term "professional" indicates that one either has a degree in art or as an artist, supplements his/her living and that creating art is a significant part of his/her career.

MEDIA: Code No.

1. Paintings, Oil or Acrylic in Oil Techniques	5. Pastels

SPECIFICATIONS: All watercolor, other two dimension and photography must be matted and ready for hanging. All two dimensional artwork must be framed or properly finished with screw eyes and wire, ready for hanging. Any artwork with saw-tooth hangers will not be admitted. Exhibits must meet these requirements or they will be rejected. Limited size on paintings: 28 x 40, unless personally delivered and picked up. All entries sent in must be prepaid and shipped to arrive between October 11th and October 13th, 2015. Deliver or address all entries to Russell's Original Art Review, c/o Patty Driscoll, Chairperson, P.O. Box 94, Russell, KS 67665. A **minimum** entry fee of \$15 will be charged, which will allow two entries. There is no limit on the number of entries. Fees, entry cards and artwork should be brought to the 4-H Building. Make checks payable to R.O.A.R.
EXAMPLES: One or two entries - \$15, three or four entries - \$30, five or six entries \$45, etc.

RESPONSIBILITY: All entries must be picked up at 4 p.m. on October 18th, at the close of the exhibition, including rejected entries. All rejected entries will be kept in the 4-H building until pickup time. Any artwork not picked up on the 18th will be left at the 4-H Building. We are not responsible for any damage or breakage.

AWARDS: Approximately \$3,200 in cash will be awarded **at the discretion of the judge.** There will be non-purchase awards. Award money will be presented at 3:45 p.m., Sunday, October 18th, 2015.

SALES: Every effort will be made to promote sales, A commission of 20% will be charged on all sales. **No work may be withdrawn before the closing date of the exhibition. All accounts must be settled, and pickup arrangements must be made by 4 p.m., October 18th, 2015.**

SCREENING: Artwork will be judged and juried.
